4. You must be prepared to have your pets **spayed or neutered** to prevent unwanted litters.
5. If you are not committed to caring and loving this pet for its lifetime, **don't take it home.**
6. Pets adopted from this shelter are **indoor pets only**. We cannot allow them to be adopted to outside homes and the neglect this brings.
7. Animal Protectors reserves the **right to repossess** any animal found to be **neglected** and/or **living in outdoor conditions**.
